# Vice President for Diversity, Equity and Access

One of our greatest public servants, Robert Kennedy, once wrote, "America's answer to the intolerant man is diversity."

Merriam Webster Dictionary defines

*Diversity:* the condition of being diverse: especially the inclusion of diverse people (as people of different races or cultures) in a group or organization.

*Equity*: justice according to natural law or right; specifically: freedom from bias or favoritism. *Access:* permission, liberty, or ability to enter, approach, or pass to and from a place or to approach or communicate with a person or thing.

Many have often asked what are the responsibilities of the VP for Diversity, Equity and Access?

The Vice President for Diversity, Equity and Access coordinates the work of several key committees within the organization (A.P Committee, Community-Based Liasion, Government Relations and Human Relations Committee). As the voice of these committees, it is also the role of this Vice President to reach outside the association in an effort to enhance relationships with parallel committees in other State and Regional Associations across the country. It is critical that this individual be a knowledgeable advocate in representing related needs of the membership.

I have had the opportunity to work with such wonderful and diverse people. This past year has been quite rewarding for me and NYSACAC. I am both honored and humbled to have the opportunity to work with such dedicated committee chairs and co-chairs.

So, what are you doing at your high school or college/university to advance the mission and purpose of diversity, equity and access? Many times when we think of diversity, equity and access, the first subject that comes to our mind is racial or ethnic diversity. This, of course, is the result of the ever-present controversy over issues of affirmative action in our profession. Despite the contentious atmosphere surrounding this issue, many forget our society was built on the idea that diversity, equity and access is tantamount to strength.

Diversity in our profession is not simply defined by the racial characteristics of the membership. Rather, diversity, equity and access are also intellectual, geographical and ideological; NYSACAC can have the greatest opportunity to improve and increase the membership and diversity at many of our institutions.





# College Admissions: Making Your HS Student "A STAR"

Ed Woodyard is the President of CollegeAdvice, a college admissions consulting service based in Armonk, NY, and serves as an independent college admissions consultant as well as a member of NYSACAC. This article was adapted from his book, <u>Getting Into the College of Your Choice: A Parents' Guide to the College Admissions Process</u>, which is awaiting publication.

It can seem unfair when one applicant is successful over another, especially when the denied or waitlisted student may have been more adept in more categories than the accepted candidate. In truth, the unknown variables of admission change yearly on every campus.

In today's extremely competitive college acceptance environment, GPAs, test scores, recommendations and essays are not enough. Often it is finding, recognizing and emphasizing "something extra" that a student will bring to a college campus. That "something extra" is a special project solely identified with the student and is most effective when originality, creativity and enterprise separate the student from thousands of other applicants.

It usually takes five things to give students "A STAR" quality. The five points that make "A STAR" shine at a college admissions office are Academics, Stature, Tests, Altruism, and Reputation (A STAR).

*Academics* means having an outstanding transcript which shows top grades and a balanced but rigorous curriculum. The course load should challenge the student to do as well as possible.

Stature allows students to demonstrate personal characteristics of confidence, commitment, leadership, discipline, teamwork, and responsibility; such accomplishments acknowledge their quest for excellence outside the classroom. Performance and participation in athletics do count.

*Tests* relate to the standardized exams of most concern for college-bound students: the SATs, SAT Subject Tests, and the ACTs -- in addition to all those classroom tests taken to get the best grades possible.

Altruism is giving of one's self to school, hometown and others. Volunteering for community service and actively participating in extracurricular activities (clubs, organizations, groups in or out of school) demonstrate selfless qualities that show how the student puts others first.

Reputation assesses a student's character, perceived by others, especially in considering recommendations from teachers, mentors, employers, alumni/ae, coaches and friends.

After the five points of being "A STAR" are identified, a specific strategy commences, aimed at making that star shine most brightly in admissions offices. The successful conclusion to a strategy is based on teamwork and preparation. As in any quest, it is advantageous to know where you want to go and find the best pathway to get there. While the highways are the same, the routes to get there can be different.

# Chief Delegate Report

With outside temperatures hitting the mid-nineties and bats flying about at night, the pulse of the NACAC Delegates Assembly remained high, despite the air conditioned rooms of the Hilton Hotel in Austin, Texas. This year 250 delegates gathered for two meetings and a full agenda.

NYSACAC delegates had been preparing for this Conference since the spring. The NACAC leadership did an outstanding job this year in encouraging delegates to review the Assembly issues starting in the Spring of 2007. The NACAC E-List was a buzz discussing all of the issues making assembly very productive.

I think we were all more excited than usual given that two of our NYSACAC colleagues were running for positions on the NACAC Board of Directors. We were (and are) so proud of Richard Alvarez and Scott Hooker for agreeing to run for national office. Congratulations to Richard and Scott, who were elected by the Assembly to the Board of NACAC.

As was the case last year, nominees presented a prepared speech but stayed at the podium in front of the entire Assembly and answered one question, which they had not seen in advance.

After the candidates were elected, the Assembly heard discussion on several key issues. To begin, two motions came before the Assembly: The Mackin motion and the Jump motion. In both cases the assembly approved these motions dealing with changes to the SPGP. The Assembly had a long debate and discussion about a third motion asking that the Delegates reverse the work of the 2006 Assembly with regards to when colleges can notify students of the institution's decision. After careful deliberation and thoughtful comments, the Assembly did change the SPGP and removed the September 15th deadline for notification of admission decisions. Overall, the level of discussion and topics raised during Assembly were evidence of the strong leadership in this association.

I want to personally thank all of our NYSACAC delegates for their hard work and dedication in preparing for and carrying out their responsibilities at Assembly. A big thank you to NYSACAC current President Sean Kaylor (Marist College) and President-Elect Mike Acquilano (Staten Island Academy) for serving as Delegates. I would also like to thank Ann Wallace and Marjorie Jacobs for serving as Alternate Delegates.

Throughout the year, please contact your delegates with questions about NYSACAC. They represent you, the NYSACAC membership, and we all work towards making our organization stronger. As this was my last year of a three-year term as delegate, I simply want to say how much of a pleasure it was to represent NYSACAC at the last three Assemblies. I encourage everyone to become more deeply involved in all NYSACAC initiatives. It is truly rewarding.
